- 1. Whereas, the rates quoted by M/S Unique Enterprises, Jammu for supply of Machinery and Equipments items for Newly Established Polytechnics of the J&K in response to this Directorate NIT No. DTE/Pur/2016-17/Tender/459-61 dated:- 03-01-2017 were approved by the State Level Purchase Committee.
- Whereas, this Directorate placed supply order's to M/S Unique Enterprises, Jammu issued under endorsement No. DTE/Pur/2016-17/70/595-97 dated:- 13-03-2017, DTE/Pur/2016-17/70/649-50 dated:- 13-03-2017 and DTE/Pur/2016-17/70/659-61 dated:- 13-03-2017.
- 3. Whereas, despite many time extensions given to it, M/S Unique Enterprises, Jammu did not supplied any requisite machinery and equipment. Accordingly, vide Office Order No. 887 of 2017 dated:- 12-10-2017 issued vide endorsement No. DTE/Pur/02/2017-18/284-93 dated:- 12-10-2017, in pursuance to the decision of the State Level Purchase Committee meeting held on 11-09-2017, all of the aforementioned supply orders in favour of M/S Unique Enterprises, Jammu were cancelled forthwith. Further, in reference to the terms and conditions as envisaged under the said NIT, M/S Unique Enterprises, Jammu was blacklisted/debarred from participating in any tendering process of this department in future.
- 4. Whereas, M/S Unique Enterprises has now been approaching this Directorate time and again with the plea for reviewing of the Blacklisting decision. Taking a lenient view, the SLPC in its meeting on 25-11-2015 has decided that M/S Unique Enterprises shall no longer be blacklisted but shall be barred from working with Department of Technical Education, J&K any further. Also, the supply orders placed to the firm remain cancelled.
