

For and on behalf of the Governor of Jammu and Kashmir State, e-tenders are invited from the Registered Firms / Manufacturers & their Authorized Dealers for the Supply of Machinery Equipments etc. for use in Newly Established Polytechnics of J&K State under centrally Sponsored scheme/ITIs under Prime Ministers Reconstruction Programme (PMRP - II). The Tender document can be downloaded from jktenders.gov.in against Non-refundable/transferable Demand Draft amounting to Rs. 1000/- per Group (Rupees One Thousand Only per Group) pledged in the name of Accounts Officer Directorate of Technical Education, J&K on the Terms and Conditions given below.

Covering:

The Bidder/Tenderer shall submit their bids in two cover system.

1. Cover- I "Technical Qualification". Will contain

- A. Call Deposit Receipt as prescribed
- B. Attested copies of the following documents.
 - i) PAN, TIN, CST Numbers.
 - ii) Balance Sheet for last three years duly authenticated by Chartered Accountant.
 - iii) Registration Certificate in English from commercial taxation department for the items he is registered.
- C) Item-wise Literature / Pamphlets etc where applicable.
- D) An affidavit duly attested by 1st Class Magistrate on Non-Judicial Paper to follow the decisions of SLPC.

2. Cover II will contain

- A. Price bids in which Bidder/Tenderer shall quote their rates for items which have been advertised strictly on prescribed BoQ document only (The Cover -II "BoQ" shall only be filled online and IN NO CASE shall the hardcopy be submitted offline).
- B. Company Price List.
- C. Company Authorization for selling the products.

GENERAL CONDITIONS.

01	Financial bid of only those Bidders/Tenderers shall be opened and considered for evaluation that would be declared successful in technical qualification, by technical Committee/SLPC.
02	The Bidder/Tenderer shall have to provide warranty for a period of one year from the date of installation.
03	The successful bidder / Tenderer shall have to provide training to the identified officials of the Department to operate the Machinery at the place of installation to the entire satisfaction of Institution.
04	The Bidder / Tenderer should attach a copy (self attested) of PAN/TIN/CST, Balance Sheet, Registration certificate from commercial taxation department, Company's Price list with the bid which shall be verified in original before placing supply orders.
05	In case Bidder / Tenderer is not a manufacturer himself, he should submit original business authorisation certificate from manufacturer.
