Covering:

The Bidder/Tenderer shall submit their bids in two cover system.

1. Cover- I "Technical Qualification" Will contain

- A. Call Deposit Receipt as prescribed
- B. Attested copies of the following documents.
 - i) PAN, TIN Number/GST registration certificate from Commercial Taxes Department
 - ii) State Tax/ GST clearance certificate for last three years filled by bidder and acknowledgement from the Competent Authority.
 - iii) Balance Sheet for last three years duly authenticated by Chartered Accountant.
 - iv) Registration Certificate in English from Commercial Taxation Department for the items he is registered.
 - v) Turnover of the Company during last three years should be minimum Rs. One (01) Crore per year.
 - vi) The Bidder shall have to upload the scanned copies of all documents duly stamped and signed by the bidder on each page. The copies of the document to be uploaded must be clearly readable.

- C) An affidavit duly attested by 1st Class Magistrate on Non-Judicial Paper to follow the decisions of SLPC.

2. Cover II “Financial Bid” will contain

- A. Price bids in which Bidder/Tenderer shall quote their rates for items which have been advertised strictly on prescribed Tender document only.
B. Company authorization for quoting the rates for this Tender.

GENERAL CONDITIONS.

1	Financial bid of only those Bidders/Tenderers shall be opened and considered for evaluation that would be declared successful in technical qualification, by technical Committee/SLPC.
2	The Bidder/Tenderer shall have to provide warranty for a period of one year from the date of installation.
3	The successful bidder / Tenderer shall have to provide training to the identified officials of the Polytechnics and ITI's to their entire satisfaction.
4	The Bidder / Tenderer should attach a copy (self attested) of PAN/TIN/GST, for last two years, Balance Sheet, Registration certificate from Commercial Tax Department with the bid which shall be verified in original before placing supply orders.
5	In case Bidder / Tenderer is not a manufacturer himself, he should submit original business authorization certificate from the manufacturer.
6	Offers should be supported by visuals, pamphlets and relevant literature
7	In case, of any shortfall in the ordered supply by the Bidder penalty @ 5% (Five percent) of the total cost of the order shall be recovered from him/ them.
8	Any other clause if found necessary shall be entered in the agreement to be executed with the department by the approved Agency.
9	Rates quoted must be inclusive of all taxes applicable (GST, Entry Tax, Other taxes & other charges etc). Bids/Rates offered exclusive of taxes shall not be considered.
10	The successful Bidder / Tenderers shall have to furnish Security Deposit equivalent to 5% of the successful bid offer in the form of Bank Guarantee during warranty period from any Nationalized Bank pledged to Accounts Officer, Directorate of Technical Education, J&K. Such Bank Guarantee shall be furnished within 15 days (Fifteen Days) from the date of issue of supply order. It would be in addition to the CDR/ FDR submitted with the bids.
11	The minimum Turn-over of the bidding company during last three audited financial years should be minimum Rs. Two Crore per year.
12	The rates are FOR destinations.
13	The rate contract finalized with the successful tenderer shall remain in force for one year from the date of its approval.
14	Each Bid/Offer shall be accompanied with a “Call Deposit Receipt/ Fixed Deposit Receipts” equivalent to Rs. 1,20,000/- for group “A”, and Rs.2,20,000/- for group “B” separately from any scheduled bank pledged

	to the "Accounts Officer, Directorate of Technical Education, J&K, Jammu". No Cheque or Bank Draft in lieu of Call Deposit Receipt/FDR shall be accepted in any case.
15	The Bidder / Tenderer can bid either for one group or two groups. Where a bidder/tenderer submits bid for more than one group, the earnest money as prescribed shall be deposited separately.
16	Rates shall remain valid for a period of One Year from the date of finalization of rate contract.
17	In case if any condition not laid down in e-tender decision of SLPC shall be final.
18	In case of any dispute arising between Tenderer and Department regarding incorporation of any of the terms and Conditions of the e-tender or any matter connected or incident, the decision of SLPC shall be final, conclusive and binding upon the parties. All the disputes between the parties evolving legal intervention shall be subject to the jurisdiction of J&K High Court.
19	Tender documents downloaded from official Web site jktenders.gov.in shall have to be appended with Rs.1500 /- (Rupees Fifteen Hundred Only) as cost of tender document in shape of DEMAND DRAFT pledged to Accounts Officer, Directorate of Technical Education, J&K.
20	The Director, Technical Education, J&K(Chairman SLPC) reserves the right to accept or reject any tender or part thereof without assigning any reason/reasons thereof.
21	Financial Bid should not be submitted off line mode.
